(FOR PROVISION OF HARBOUR TOWAGE SERVICES)

1. TOWAGE SERVICE CHARGE

The following charges shall be payable for towage services:

(vi) Vessel above 20,000 GT and up to 30,000 GT	S\$680.00	S\$340.00
(vii) Vessel above 30,000 GT and up to 60,000 GT	S\$840.00	S\$420.00
(viii) Vessel above 60,000 GT and up to 100,000 GT	S\$1,100.00	S\$550.00
(ix) Vessel above 100,000 GT	S\$1,260.00	S\$630.00
(x) Oil rig, vessels of unusual characteristic regardless of its tonnage and all types of barges except flat top and dumb barges of below 6,000 GT	S\$1,260.00	S\$630.00
(xi) Special request for tugs above 45 tonnes bollard pull	S\$1,700.00	S\$850.00
(xii) Emergency tug assistance including but not limited to anti-pollution and rescue services	S\$2,500.00	S\$1,250.00

For the purposes of computing the service charges payable, towage service shall be deemed to have commenced from the service required time and shall be deemed to end after completing the towage service. Travelling time to and from each towage service Pick Up and Let Go points respectively shall be charged in accordance to the Standard List of Pick Up and Let Go Time. A copy of this Standard List is available upon request.

In the event that the tug arrives later than the service required time, the service charges shall commence from the time of the tug's arrival. In the event that more than one tug is required, the service charges shall commence from the arrival time of the last tug.

2. TOWAGE SERVICE AMENDMENT/CANCELLATION CHARGE

- (a) Where a tug is ordered for and such order is amended or cancelled less than two hours before the service required time, such tug shall be deemed to have been used for one hour. The charge for the use thereof for one hour shall apply for each amendment/cancellation under Item 1 above
- (b) Where a tug is ordered, dispatched and is no longer required the service charges under Item 1 above shall apply.
- (c) Where an order for towage service is cancelled as a result of the tug/s arriving more than one hour later than the service required time, cancellation of services charges incurred shall be waived.

3. BUNKER SURCHARGE

Bunker surcharge will be applicable with effect 1st September 2003.

The surcharge will be adjusted monthly in accordance to the price of bunkers.
